RE: Cultural Review for Application 14-123251-00-100 (Rosemont Copper Company)

Dear Mr. Romero:

Rosemont Copper Company filed a new Right of Way (ROW) application (14-123251-00-100) with the Arizona State Land Department (ASLD) for the installation and maintenance of an access road, fresh water pipeline, tailings pipeline, process water return pipeline, electrical services and telecommunications on State Trust Land in Pima County (T18S, R15E, Sections 16 and 21), encompassing 11.433 acres. Therefore, per the 2016 Interagency Service Agreement (ISA) between the ASLD, the State Historic Preservation Office (SHPO), and the Arizona State Museum (ASM), the area cited in the above-captioned application has been reviewed in comparison to ASLD's cultural resource records. This review is undertaken to make a recommendation to ASLD's ROW Section regarding any properties which may be eligible for the Arizona Register of Historic Places that are known to be located within or nearby the requested ROW. In addition, to make a recommendation to ROW Section regarding of any efforts ASLD should ask the applicant to undertake to identify currently unknown Register eligible properties potentially affected by ASLD granting the ROW application (14-123251-00-100).

The results of this research revealed that two cultural resources inspections have been completed within and covered the entire area cited in the application (1987-264.ASM and 2010-368.ASM). No cultural resources have been identified within the subject area. Per SHPO Guidance Point No. 5 about relying on survey data from projects conducted more than 10 years earlier, ASLD Cultural Resources Section reviewed documentation for the outdated records and found that the methods used meet current standards. However, ASLD Cultural Resource Section Recommends new survey for projects completed prior to 1995 when the ASM site definition was revised.

Therefore, the ASLD Cultural Resources Section recommends that the applicant arrange for an archaeologist permitted by the Arizona State Museum (ASM) to inspect and evaluate the areas

surveyed prior to 1995 of this area of State Trust land prior to ASLD granting ROW application 14-123251-00-100.

By copy of this letter to Rosemont Copper Company the Arizona State Museum (ASM) has a list of permitted contract companies with the qualifications to complete standard scientific field work in Arizona. ASM can be contacted at 520-621-2096 or a list of permitted consultants can be downloaded at https://statemuseum.arizona.edu/crm/document/aaa-qualified-consultants. Once the inspection has been completed, reports submitted to the ASLD Cultural Resources Section must conform to SHPO Standards (https://azstateparks.com//shpo-survey-report- standards) for review in compliance with ASLD's statutory obligations under the State Historic Preservation Act (SHPA) (A.R.S. § 41-861 et al). The cultural resources inspection will provide a document to assist the ASLD Cultural Resources Section in determining if any cultural resources eligible for nomination to the State and Federal Registers of Historic Places are present. If registereligible properties are present, and avoidance is not feasible, then additional fieldwork may be required.
